POOL OPENING INCLUDES: Removal of cover, winterizing plugs and antifreeze where possible and practical. Reinstall jet eyeballs, lights, handrails/ladders, diving board, pump & filter plugs, sanitizing equipment, and gauges. Exposed piping and equipment will be inspected, and circulation established. Heaters will be test-fired but turned off unless notified otherwise. **Startup chemicals, cleaning or vacuuming of pool is NOT INCLUDED but is an optional add-on.**

NOTE: Complex systems/features, 50K+ gallon pools, that require additional labor will be assessed and billed in addition accordingly. Openings outside 15-mile service radius will incur travel charges in addition to this contract. System repairs are not included in this opening contract. Such instances less than \$75 will be completed at the time of opening to establish circulation/filtration and billed in addition; instances over \$75 will be authorized with homeowner and rescheduled at earliest availability. Customer must have water at operational level (half-way into skimmer). Customer will be billed at normal service rates for required return trip if job cannot be completed as scheduled.

Salt Cell Cleaning: \$30.....
 (Diluted acid solution to dissolve calcium build-up on cell blades. Should be performed 1-3 times per year)

Vacuuming: \$145.....
 (Up to 1 hour. Vac cannot be completed unless bottom can be seen. Charge will be refunded or service rescheduled)

Travel (over 15miles) upcharge: \$35.....

Terms & Conditions

Please Read & Sign Below:

Barton Pool Company / Barton Pool Service herein known as/referred to as "Company":

1. Opening Services as per work described on Opening Contract. Company will not be expected to perform any work other than that which is herein contracted. Company cannot be held responsible for damages created by other persons.
2. Water/Excess debris from top of cover must be removed before service visit may take place. If an additional trip/time is required, Customer will be billed additionally on a time and materials basis.
3. Company is not responsible for any items under the care of the homeowner during winter months. All damaged or corroded parts not fit for reuse will be replaced and billed to the homeowner within aforementioned \$75 threshold. If company cannot finish opening, standard service rates will be assessed when we return to finish opening the pool.
4. Company must have access to: property, pool/pool equipment area, outside working electrical outlets, and outside working water service. These outlined working conditions not met may incur return fees at normal service rates.
5. Company not responsible to fill pool and/or spa to operational level within reason/timely accommodation.
6. Company must have access to items removed from the pool structure and pool equipment when pool was winterized.
7. If pool equipment is inside home, homeowner must be home for entire pool opening.
8. Company will not be held responsible and/or liable for damages or added expense for delays of contract date caused by shortages including but not limited to; availability of parts, accessories, etc. or weather conditions, strikes, acts of God or other circumstances beyond the control of Company or for any ensuing damage and/or operational expense caused by said delays. Service work to complete the opening may be rescheduled at our earliest convenience
9. Due to circumstances outside Company's control, Company does not warranty pool service work or make an expressed or implied warranty of pool structure, deck, piping or any associated pool equipment.
10. Company will not assume responsibility and/or liability for damages to lawns, shrubbery, landscaping/hardscape including potential run-off to neighboring properties, due to backwashing, draining, and/or cleaning filter due to antifreeze or chemicals from the pool water.
11. At opening, Company will not be expected to be responsible for any missing or damaged items of pool equipment, stored on Owner's property under their care and keeping, over the winter months.
12. Any changes/amendments to this agreement must be made in writing, constitute the entire contract of the parties, and be signed by both parties to be binding.
13. This contract shall not be binding until Company receives a signed contract. Company reserves the right to terminate this contract at any time.
