Customer must have water drained 12-18 inches below tile-line if a mesh safety cover is used. Customer will be billed at normal service rates of \$250/crew hr for water removal or a return trip if job cannot be completed as scheduled.

#### **Terms & Conditions**

#### Barton Pool Company referred to as "Company":

- 1. Closing Services as per work described on Closing Contract. Company will not be expected to perform any work other than that which is herein contracted. Company cannot be held responsible for damages created by other persons.
- 2. Company is not responsible for any items under the care of the property during winter months. All damaged or corroded parts not fit for reuse will be replaced and billed to the property within aforementioned \$75 threshold. If company cannot finish closing, standard service rates will be assessed when we return to finish closing the pool/spa.
- 3. Company must have access to: property, pool/pool equipment area, outside working electrical outlets, and outside working water service. These outlined working conditions not met may incur return trip fees at normal service rates.
- 4. Company not responsible to drain pool and/or spa to closing height within reason/timely accommodation.
- 5. Company must have access to closing items removed from the pool structure/pool equipment when pool was opened. Any missing plugs or blowout gizmos will be replaced at normal retail price.
- 6. Company will not be held responsible and/or liable for damages or added expense for delays of contract date caused by shortages including but not limited to; availability of parts, accessories, etc. or weather conditions, strikes, acts of God or other circumstances beyond the control of Company or for any ensuing damage and/or operational expense caused by said delays. Service work to complete the closing may be rescheduled at our earliest convenience.
- 7. Due to circumstances outside Company's control, Company does not warranty pool service work or make an expressed or implied warranty of pool structure, deck, piping or any associated pool equipment. Any/all repair work deemed to be caused by improper winterization must be completed by Company; no monetary compensation or service compensation for work performed by property or other companies will be entertained.
- 8. Company cannot be held responsible and/or liability for damages to lawns, shrubbery, landscaping/hardscape including potential run-off to neighboring properties, due to backwashing, draining, and/or cleaning filter due to antifreeze or chemicals from the pool water.
- 9. At closing, Company will not be responsible for any missing or damaged items of pool equipment, stored on Owner's property under their care and keeping, over the summer months.
- 10. Any changes/amendments to this agreement must be made in writing, constitute the entire contract of the parties, and be signed by both parties to be binding. This contract shall not be binding until Company receives a signed contract. Company reserves the right to terminate this contract at any time.
